ORDER:

For a comprehensive progressive policy for the advancement, development and empowerment of women with an appropriate policy prescriptions and strategies, Government have decided to establish Mahila Viswa Vidyalayam (Women's University) in Telangana State duly upgrading the existing Women's College, Koti, Hyderabad, which is now a Constituent College of Osmania University.

- 2. The Secretary, Telangana State Council of Higher Education, Hyderabad, in the letter read above, has submitted recommendations of the Committee constituted for up-gradation of the existing Women's College, Koti, Hyderabad to that of a University.
- 3. Government after careful examination, have accepted the recommendations of the Committee for establishment of a new State University namely Mahila Viswa Vidyalayam (Women's University) by up-gradation of the existing Women's College. Koti, Hyderabad to that of a University in Telangana State from the academic year 2022-23 and decided to amend the Schedule of the Telangana Universities Act, 1991 (Act No. 4 of 1991).
- 4. Further Government also decided to create new courses along with new departments, to sanction teaching and non-teaching staff and also to extend financial support and infrastructure development, as per the provisions of the Telangana Universities Act, 1991 and also decided to transfer the assets including the teaching and non-teaching posts existing in the Women's College, Koti, Hyderabad, from the administrative control of Osmania University to the newly formed Mahila Viswa Vidyalayam.
- Accordingly, the following notification shall be published in an Extraordinary issue of the Telangana Gazette, dated.22.04.2022;-

NOTIFICATION-I

In exercise of the powers conferred under sub-section (1) of section 3 of the Telangana Universities Act, 1991 (Act No.4 of 1991), Government hereby establish a new State University namely Telangana Mahila Viswa Vidyalayam (Women's University), commencing from the Academic Year 2022-23 and the University comprising the area of Hyderabad with Hyderabad as its Head Quarters and it may extend to whole of the State of Telangana.
